

# SUCCESS STORIES: DOWNTOWN ITHACA CHILDREN'S CENTER

Four families were able to maintain employment as essential workers as a result of DICC's child care placements, affordability, schedule, safety and continuous programming with little interruptions. The families have reported their confidence, relief, appreciation, and more for how we have kept DICC as an option for their needs and wants. Specifically, families report that they feel understood and respected culturally. Given the current uncertain times related to social, racial, and economic injustices, DICC creates a safe place where children and adults maintain integrity which enhances growth and development. The four children demonstrate at least one years' developmental growth in their social and pre-academic/academic assessments during their time with DICC.

# GREATER ITHACA ACTIVITIES CENTER

"Our child has been a participant in GIAC's youth programs since July 2019. He participated in GIAC's Summer Camp and after-school program for the 2019-20 academic year. While in-person programs ceased in March 2020, he continued to do online programming until early May 2020 with his GIAC leaders. As two parents who work full-time, we relied on GIAC to provide safe, educational, and culturally affirming childcare. Our son has blossomed during his time at GIAC. In pre-k and kindergarten, he was sometimes teased by other children for his hair that he would wear in braids or sometimes out in its natural curl. He also has been in speech therapy since he was 20 months old and sometimes struggled to be understood by his peers and adults. This year, he began summer camp excited, shy, and not knowing how to swim. In six short weeks he grew in many ways. He was confident in the pool and became a more skilled swimmer. He made several new friends and walked around the GIAC playground and halls with a smile, confidence, and newfound swagger. When the school year began, he walked up to teachers at Northeast Elementary and gave them enthusiastic high fives and said, "what's up!" His success is as a direct result of the culturally affirming experiences he had at GIAC. Thank you."

# **UW/2-1-1 COVID-19 RECOVERY PROGRAM**

In May 2020, the United Way of Tompkins County Board of Directors passed a resolution to invest \$55,000 of the 2019-20 campaign funds raised into "COVID-19 Recovery efforts." In June 2020, the United Way/2-1-1 COVID-19 Recovery Program was identified as the vehicle by which this investment would be distributed to community members. In collaboration with the Human Services Coalition, the program provides mini-grants of up to \$500 per qualified household to address basic needs expenses outside of food distribution. The program launched on September 1, 2020.

## **UW/2-1-1 ALICE PROGRAM**

Based on the response to the program, which included reports from 2-1-1 operators that this program provided resources to callers that would otherwise be left without responsive services, the UWTC Board of Directors resolved to continue the program as originated except to remove the requirement that the household have a COVID-19 impact. All households living below the United Way ALICE threshold\* became eligible for the program as of July 1, 2021. \*ALICE is an acronym for Asset-Limited, Income-Constrained, Employed households who live below a "survival" budget threshold that is determined bi-annually by county.

SUCCESS STORIES: 2-1-1 AND UNITED WAY/2-1-1 COVID-19 RESPONSE PROGRAM

"I was living at Second Wind Cottages and called and asked for some help getting clothes for the winter for construction work, and also needed general help. 2-1-1 connected me with Human Services Coalition's Community Health Outreach Specialist, who helped me with a lot--not only clothes, but health insurance, and I'm even enrolled in some college courses now. They also helped me use the United Way/2-1-1 COVID Response Program to pay for a Spectrum bill so that I could have internet as I looked for and got construction work. I called back to say I refer all of my friends to 2-1-1 and HSC and that you've all changed my life."

"My vehicle was impounded due to a clerical error but I was still responsible for the towing and daily impound fees, which I couldn't afford as I had a loss of income related to the COVID pandemic. The United Way/2-1-1 COVID Response Program paid these fees and also helped me get rides so I could get my vehicle back. I don't know what I would have done without this help, I needed my car to get to interviews to find a job."

This funding can be used as start-up funds or as leverage to secure additional funding, and is not intended to be an ongoing source of revenue.

## **WEEK OF CARING, SEPTEMBER 2020**

What was once "Day of Caring" became "Week of Caring" as
UWTC opened up its offices to receive donated food, hygiene
and cleaning items, and school supplies all week in a safe
manner. The week culminated on Friday with the Stephen E.
Garner Day of Caring which distributed an estimated 2,500
pounds to all Tompkins County Food Pantries. Community
members and several workplaces in Tompkins County joined
together for this annual drive, including Tompkins Trust
Company, Cornell University, CFCU Community Credit Union,
Wegmans, and HOLT Architects.



UWTC continued working with various community partners throughout the year to provide food deliveries to residents who could not get to food pantries in person, whether due to transportation, illness, or being quarantined.

## **SUCCESS STORY: JAMES (FOODNET MEALS ON WHEELS)**

James was referred for our home delivered meals and nutrition counseling services by his medical provider after recently starting on newly prescribed insulin to manage his diabetes. When James was contacted for his initial assessment, it became apparent that he was struggling with food insecurity and other health concerns. He also reported that his eyesight and mobility were compromised from uncontrolled diabetes. James lives alone, without family or friends nearby to support shopping, cooking or preparing balanced meals.

Foodnet's registered dietitian has been providing nutrition counseling regarding carbohydrate control, and diabetic diet education, which includes helping James with menu selection to optimize his new insulin regime. James checks in multiple times each week with Foodnet's registered dietitian for follow-up. After working with Foodnet's dietitian, James reports that his blood glucose is typically in a normal range and his most recent blood work indicated much better glycemic control over the past 3 months. He reports more energy, improved mobility and a better outlook on life, thanks in part to Foodnet's home delivered meals and the nutrition counseling that he received.



United Way ensures that donor dollars are well-invested by tracking and measuring the outcomes of funded programs. Volunteer reviewers, with the approval of the UWTC Board of Directors, award CCF grants to local programs that can provide measurable, positive outcomes and that address identified priorities to meet community needs.

Many programs address more than one pillar. Due to COVID-19 impacts, this year the UWTC Board of Directors assigned the highest priority to financial stability programs, followed by health programs, and then by education programs.


